THIS WELL WAS ORIGINALLY SHUT IN DUE TO HIGH WATER PRODUCTION AND A LACK OF WATER DISPOSAL. THE WELL WAS TEMPORARILY ABANDONED ON 11-18-11 WITH A CIBP @ 4890' IN ORDER TO RUN A MECHANICAL INTEGRITY TEST. AS THERE WERE NO IMMEDIATE PLANS TO RETURN THE WELL TO PRODUCTION, THE CIBP WAS LEFT IN THE WELLBORE. THIS WELL PASSED THE MIT ON 11-29-11 AND IS EXPECTED TO REMAIN IN TA STATUS UNTIL 2016.
