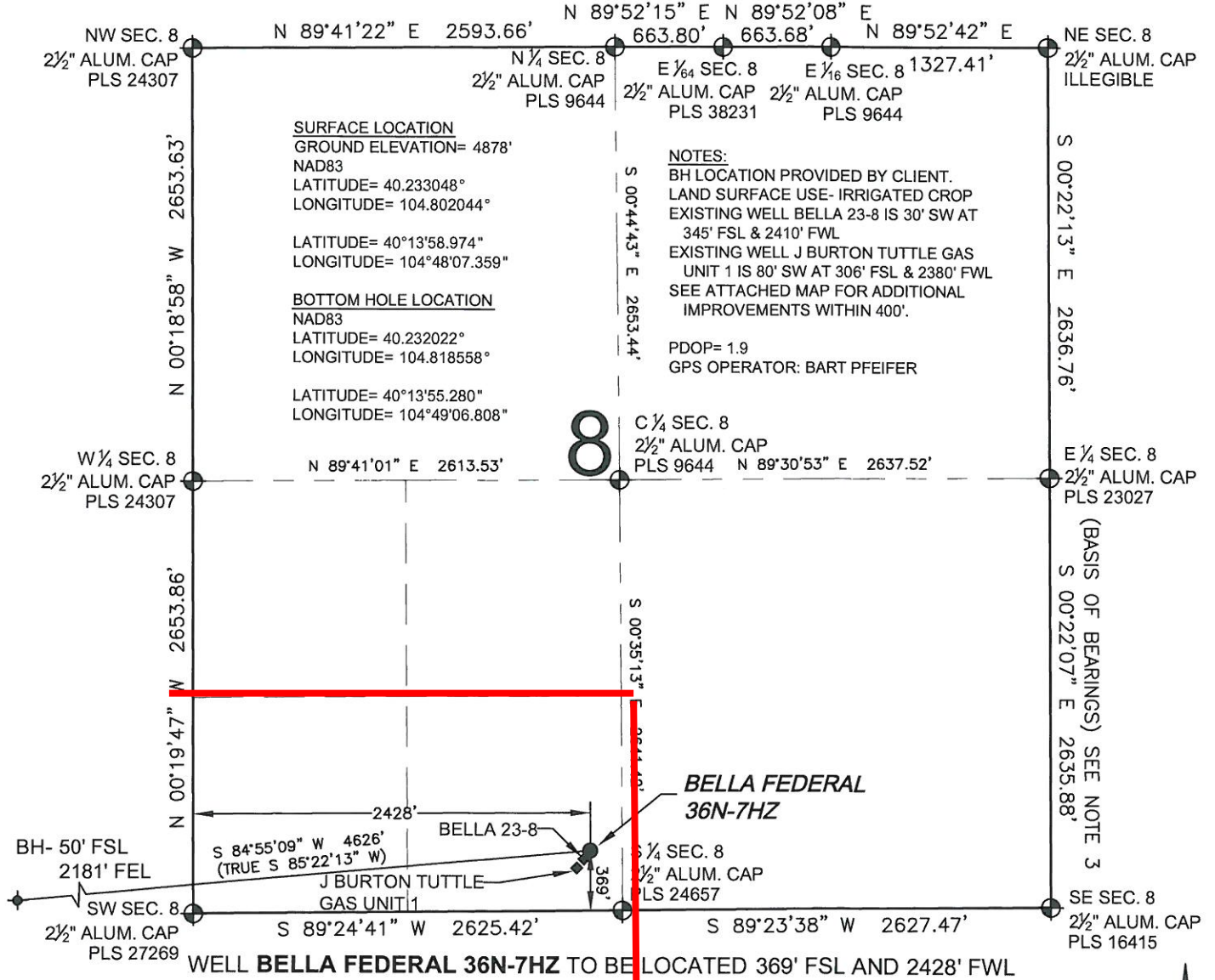

WELL LOCATION CERTIFICATE: BELLA FEDERAL 36N-7HZ

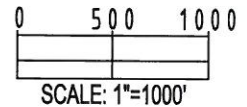

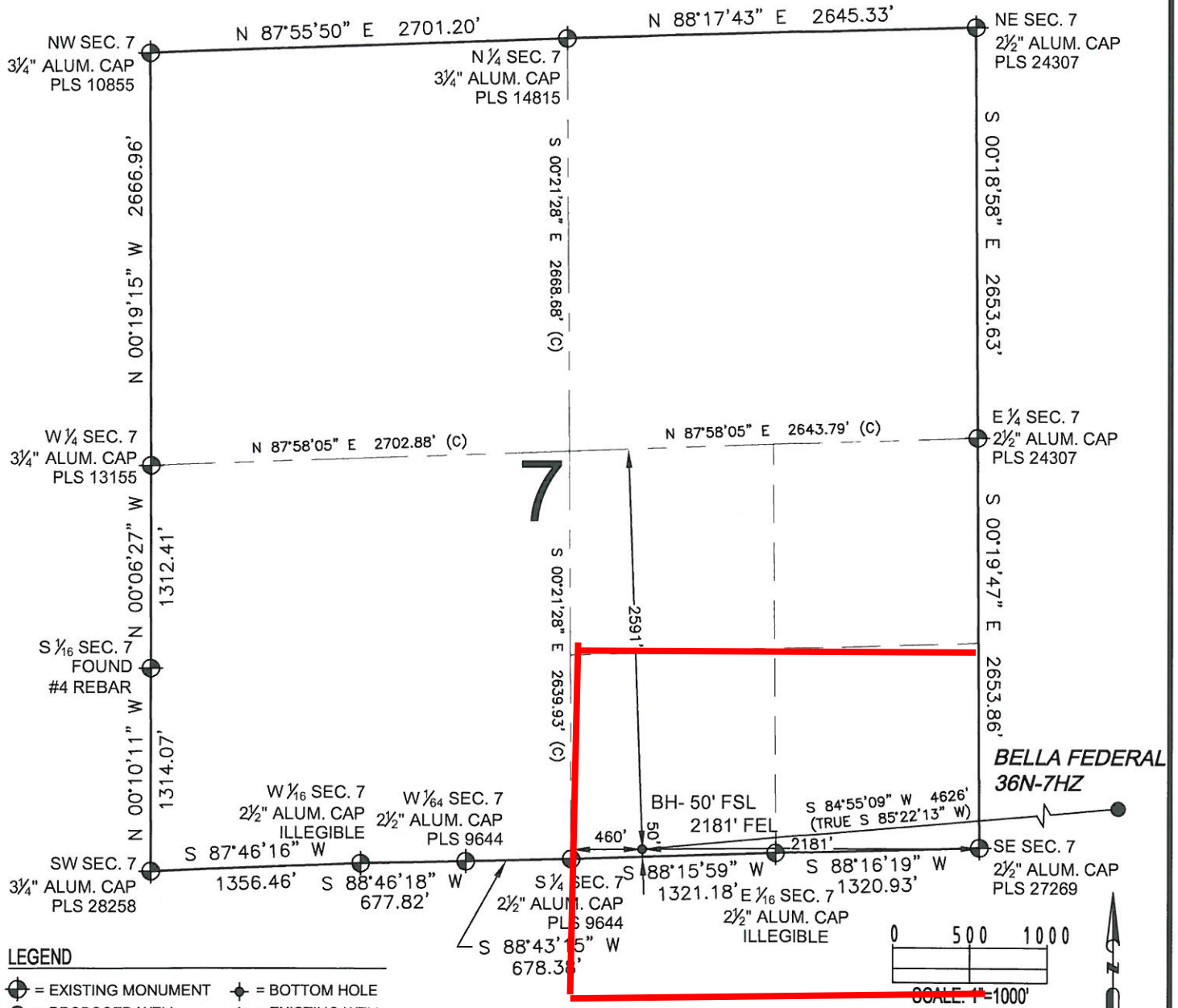
