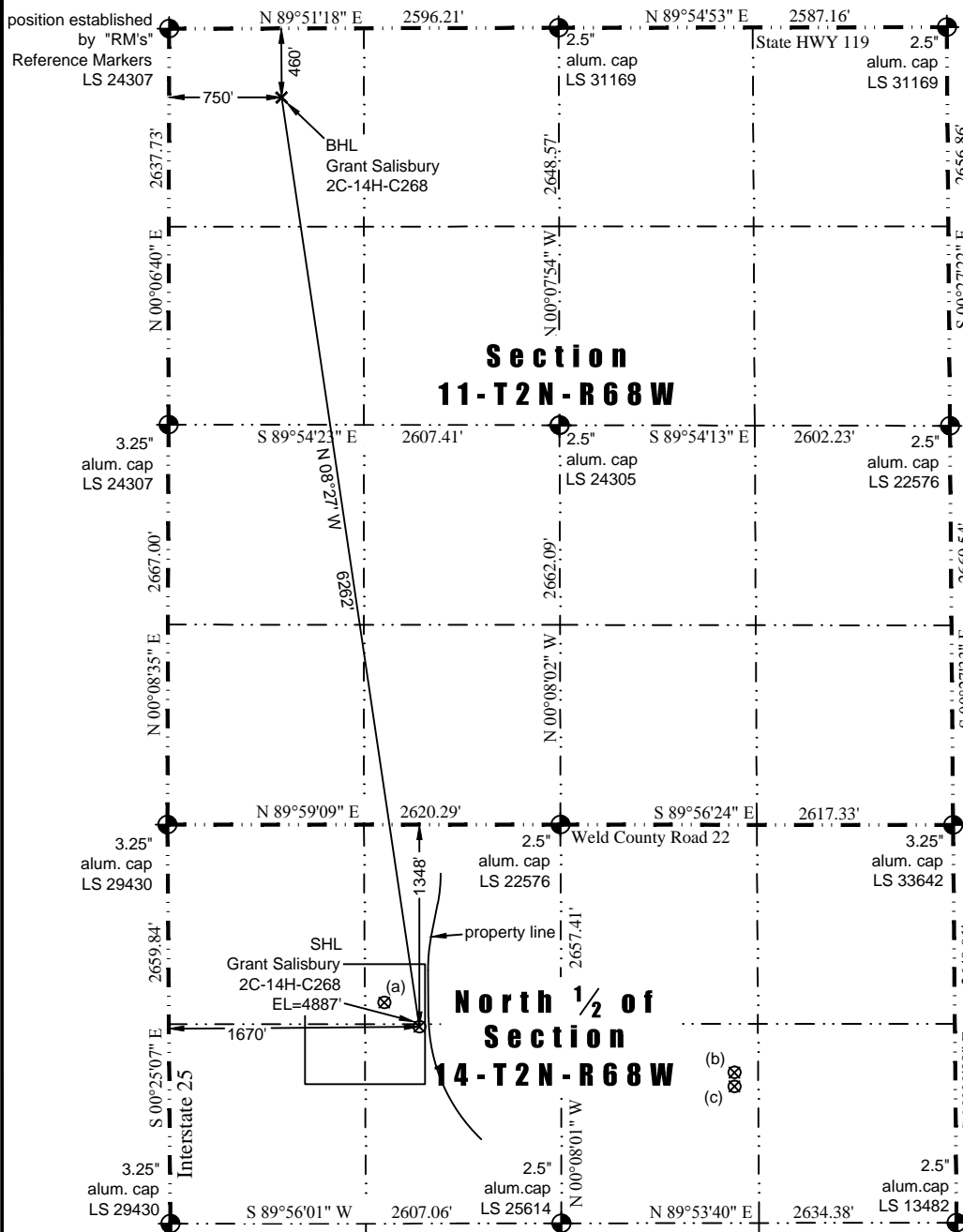

WELL LOCATION CERTIFICATE

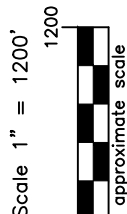
