On May 29, 2013, the Weld County Department of Public Health and Environment conducted a routine inspection of the Apollo Operating Class II Injection Disposal Facility, located at 33525 Highway 392, Weld County, Colorado. The purpose of the inspection was to assess the facility's compliance with Site Specific Development Plan and the Amended Use by Special Review Permit Number 1679 (AmUSR-1679) and the Weld County Code. A copy of the inspection form is attached. Based on the inspection, the facility was in substantial compliance with AmUSR-1679.

As a follow-up to the Department's October 10, 2012 inspection the following items have been addressed as follows: the Department confirmed that the storage/processing tanks outside the secondary containment area have been emptied and has approved the request to amend the approved groundwater monitoring plan to allow semi-annual sampling.
