Susan,

I have completed my review of the Form 2A for the ROHN STATE LD10-65HN oil and gas location and I have a few comments.

1) It appears that the Hydrology Map submitted with this Form 2A is for the nearby ROHN STATE LD10-67HN location. Please send me the correct Hydrology Map and I will add it to the list of Attachment for this Form 2A.

2) You have shown on the Location Drawing that a low area is approximately 338 feet southwest of the ROHN STATE LD10-65HN location. Although you have indicated in the Comments that this low area will not be disturbed by operations, the outline of the disturbed area shown on the Location Drawing is very close to this low area. Additionally, a review of aerial photos shows this low area does collect standing surface water and the USGS topo map indicates it is an intermittent pond. Therefore I would like to add the following COA to this Form 2A:

"Operator must implement site specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the low area/intermittent pond located approximately 338 feet southwest of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products."
