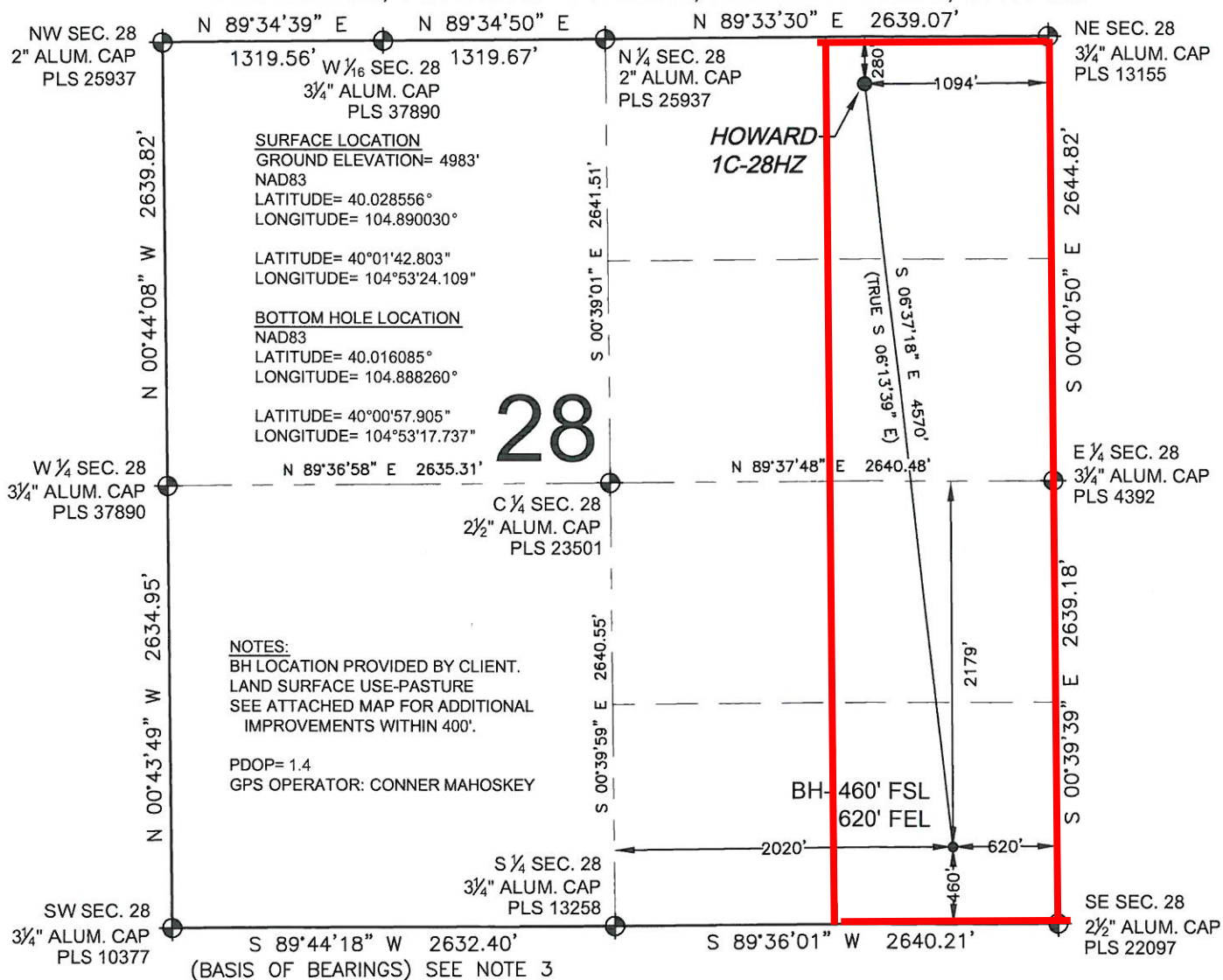

WELL **HOWARD 1C-28HZ** TO BE LOCATED 280' FNL AND 1094' FEL**LEGEND**

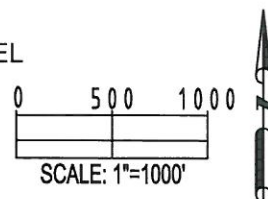
