- 5 Run 2 3/8" tubing to TD and circulate hole clean TOOH
- 6 Rig up RMWS run in and perforate Lower Cameo
- 7 Pick up 3.5" frac string with packer run in to set point and hang off
- 8 Rig up Halliburton Stim Service frac Lower Cameo
- 9 Rig up RMWS run in and perforate Cameo
- 10 Rig up Halliburton Stim Service frac Cameo
- 11 Rig up B&S Flow testers and begin flowback operations
