Chama Oil & Minerals requests approval for an unplanned sidetrack of its Weimer State 16-19-47 #1-P API 05-061-06881-01. Listed below is the pertinent information regarding the subject well.

- Well had been drilled to TD of 8,580'. Pilot hole to was drilled to 5,935'. Well was plugged back to 4,694'. Drilled curve to 5,745'. Set and cemented 7" 26# casing at

5,745'. Drilled lateral to 8,580'. Geologic interpretation shows well bore to be in target zone but in poorly developed reservoir rock. Plan to sidetrack lateral to place well bore in better developed reservoir.

- TD 8,580' MD
- 9.625" 36 ppf casing set at 508' and cemented to surface
- Fish left in hole: none
- Proposed setting depth of sidetrack plug: 5,645' – CIBP inside 7" casing, sidetrack with whipstock and mills
- Cement: none
- Proposed KOP 5,630' MD
- Objective formation is same as original – Spergen
- BHL is same as original
