Attached are the analytical laboratory reports for the SP 32-14 flowback water release and the sampling location map. The analytical results came back below the allowable concentrations specified in COGCC Table 910-1, with the exception of inorganics (SAR, EC, and pH) and arsenic (see attached laboratory report). In accordance with COGCC guidance Q32 regarding inorganics, materials with elevated SAR, EC, and pH concentrations will be buried under a minimum of three (3) feet of backfill cover to ensure successful reclamation of the site. Arsenic concentrations are below background levels in accordance with footnote 1 to COGCC Table 910-1.
