Comments:

The well was plugged on November 2, 1962 and reclaimed thereafter. Specific reclamation procedures are unknown by current Apache personnel. However, the site is currently occupied by a productive irrigated cropland. There is no evidence of a well site visible. The well, any pits, mouse or rat holes and cellars that may have existed have been backfilled; debris removed and the surface has been re-contoured back to natural topography. Aerial orthophotos as far back as 1989 show evidence that the site has produced crops.
