Joseph J Hawkins, owner of the Subject Lands, for adequate consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby waive the provisions of Rule 318.A. (a) of the Colorado Oil and Gas Conservation Commission's Rules and Regulations that provides that wells shall be drilled within a square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' Window"). Joseph J Hawkins hereby consents and authorizes Bill Barrett Corporation to drill, complete and operate the following wells:

Hawkins 5-61-21-6457BH being 300 feet FWL and 1344 feet FSL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 475 feet outside of the 400' Window of Subject Lands.

Hawkins 5-61-21-4956BH being 300 feet FWL and 1364 feet FSL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 455 feet outside of the 400' Window of Subject Lands.

Hawkins 5-61-21-4841BH being 301 feet FWL and 1384 feet FSL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 435 feet outside of the 400' Window of Subject Lands.

Hawkins 5-61-21-3340BH being 301 feet FWL and 1404 feet FSL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is approximately 415 feet outside of the 400' Window of Subject Lands.

By signing this letter you hereby grant your consent to Bill Barrett Corporation to locate the wells outside of a GWA window as defined by COGCC Rule 318A. (a). Additionally, the wells are being proposed at a surface location which is approximately 4,494 feet from an existing surface well location. By signing this letter you also grant your consent to Bill Barrett Corporation to

locate the wells more than 50 feet from the existing wells as provided for under COGCC Rule 318A.(c).
