Attached with this Form 4 submittal is the analytical laboratory report for the MV 25-17 Landfarm #1 batch 3, and Landfarm #2 batch 2 and batch 3 confirmation samples.

Samples were collected in accordance with the approved Soils Management Plan (COGCC document #2232630).

Landfarm #1 Batch #2 sampling:

2 grab samples were collected from the middle of sample grids number 1-6 and number 1-7 (25% of overall treatment area), located in Treatment Area 1, and analyzed for BTEX, PAHs, and TPH. All constituents tested below the COGCC 910-1 requirements.

Landfarm #2 Batch #2 sampling:

1 grab sample was collected from the middle of sample grid number 2-12 (100% of overall treatment area), located in Treatment Area 2 (south) and analyzed for BTEX, PAHs, and TPH. All constituents tested below the COGCC 910-1 requirements.

Landfarm #2 Batch #3 sampling:

1 grab sample was collected from the middle of sample grid number 2-1 (100% of overall treatment area), located in Treatment Area 2 (north) and analyzed for BTEX, PAHs, and TPH. All constituents tested below the COGCC 910-1 requirements.

Based on these results, WPX Energy requests COGCC's permission to return the material from Treatment area #1 and Treatment area #2 to the excavation from which it originated.
