Rule 7 requires that cement behind the production casing exist all the way to surface. Potential for remedial cement work after review of the CBL will be discussed with Elm Ridge Exploration Co, LLC (ERE).

ERE is also required to perform and submit the results of a Braden Head Pressure Test within a week following formation perforating and stimulation.
