COMMENTS:

Piceance Energy proposes to temporarily install one 40,000 bbl LVST on the referenced location.. The tank will be used to store and manage produced, fresh, and flowback water for the completion of 5 wells in the area. No additional surface disturbance will be required other than smoothing the tank site and additional berm improvements around the location edge in case of tank leakage. Manufacturer (installer) certified no complete failure of tanks in over 2000 set-ups. Tanks will be visually monitored for leaks. If any leaks are detected, the tank will be immediately drained in to other tanks and the leak repaired or liners will be replaced.

The tanks are engineered and stamped drawings are available upon request.

The tank construction consists of:

Tank walls 3/16" steel plate:

Tank Wall Connection Points: Reinforced with 4" box steel

Connecting plates are 1" plate steel with 1" pin connections.

Plates are spaced closer together as the bottom to offset increase in hydrostatic pressure

Tank Liner: double lined with 30 mil polyethylene liner

Underlayment: 10 oz geotextile underlayment to protect the line.

Once operations are completed all excess water will be removed to approved disposal sites, the liners will be removed, tank walls dismantled and removed, and location will be restored to original operations.

The tanks will be in place no longer than 90-120 days.
