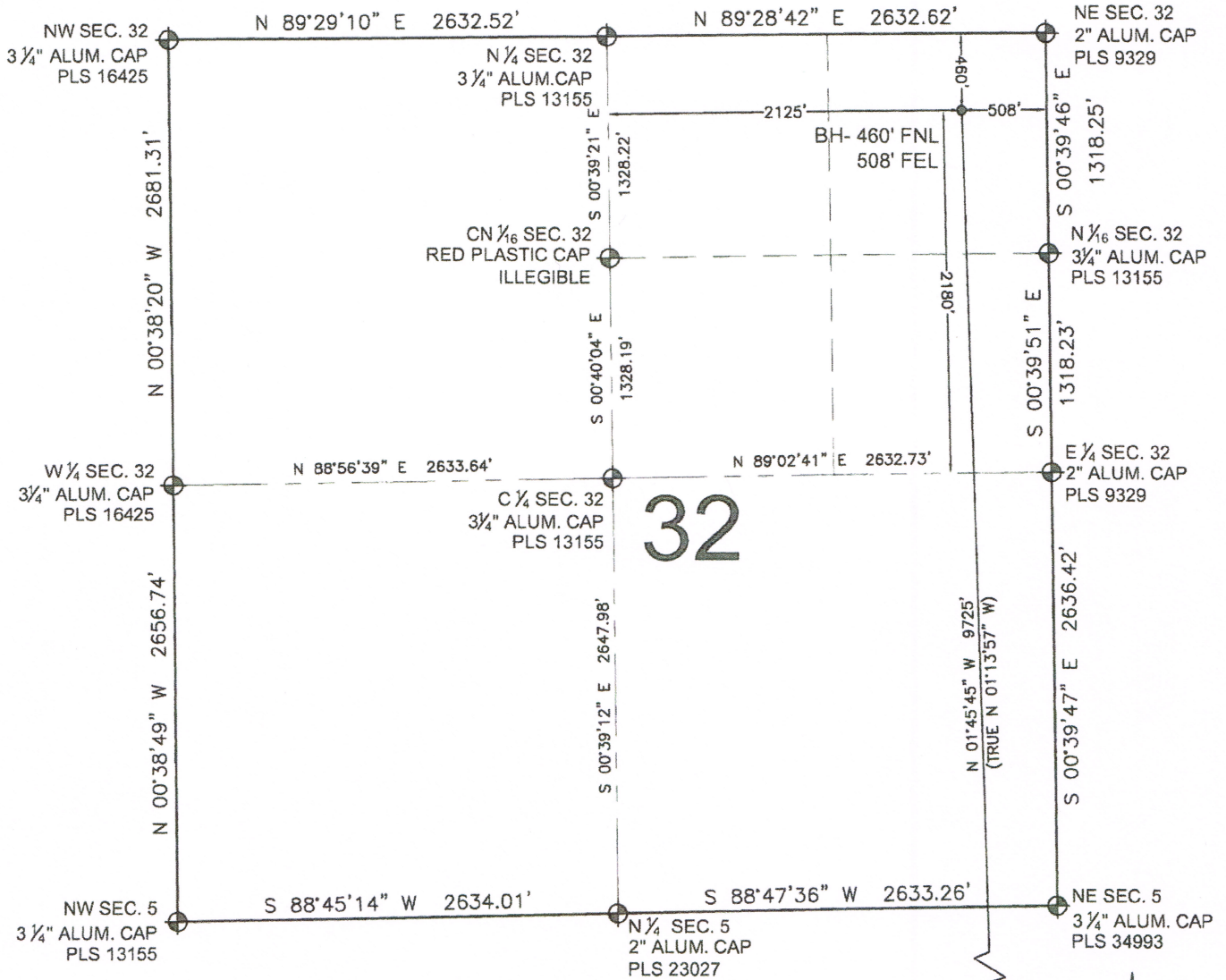




# WELL LOCATION CERTIFICATE: BOYD 1N-32HZ

SECTION 32, TOWNSHIP 2 NORTH, RANGE 65 WEST, 6TH P.M.

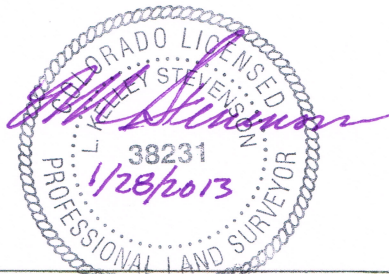

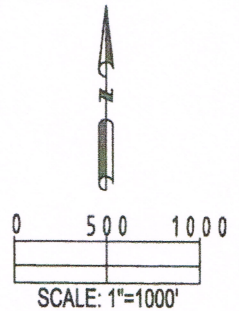
