COMMENTS:

Dejour respectfully requests permission to lay a temporary surface water line for pumping water to the water pit on well pad 21A. The proposed pumping operation will eliminate considerable vehicle traffic by eliminating many truck loads of water.

The proposed water line will be laid along the east side of the existing well pad access road (see map, line in yellow) to connect to an existing Williams water line just off of the Dejour-BLM lease. The proposed water line will be constructed using a 10" polyethylene pipe. Dejour anticipates using the proposed water line during well fracking operations in July and August 2013. The temporary water line will be removed once well fracking operations have been completed.
