Listed below are CPWs recommended BMPs for the proposed EE3 LLC Marr Pad and Damfino Pad locations.

Pad location: **Marr Pad** (previously Hebron 2-07), T7N, R80W, sect 7, 40.598347/ -106.415444

Document #: 400392924

Wildlife concerns: The proposed pad location is within greater sage-grouse Preliminary Priority Habitat, greater sage-grouse production area sensitive wildlife habitat (SWH), 3.4 miles to the nearest greater sage-grouse lek ("Railroad-new" lek), and less than 185 feet from an existing drainage. Based on the above wildlife concerns, CPW recommends the following BMPs:

1. Where oil and gas activities must occur within 4 miles of greater sage-grouse leks or within other mapped greater sage-grouse breeding or summer habitat, conduct these activities outside the period between March 1 and June 30.
2. Use hospital grade mufflers for compressors, pump jacks, or other motors necessary to run operations at the site. Mufflers will be pointed upward to dissipate potential vibration.
3. Establish company guidelines to minimize wildlife mortality from vehicle collisions on roads.
4. Restore appropriate sagebrush species or subspecies on disturbed sagebrush sites, if agreeable by the landowner. Use locally collected seed for reseeded where possible.
5. Ensure secondary containment of all stored fluids to prevent discharge into the adjacent "sensitive area" (based on proximity to surface waters and depth to groundwater).

6. Encourage developers to pipe produced water, oil, and natural gas liquids to a central facility site for transport, in order to reduce truck traffic to each well pad site.
7. Install and utilize bear-proof dumpsters and trash receptacles for all food-related trash on location, following COGCC Rule 1204 a-1.

Wildlife Concerns: The proposed pad location is within greater sage-grouse Preliminary Priority Habitat, greater sage-grouse production area sensitive wildlife habitat (SWH), 1.4 miles to the nearest greater sage-grouse lek ("Ptar" lek). Based on the above wildlife concerns, CPW recommends the following BMPs:

1. Where oil and gas activities must occur within 4 miles of greater sage-grouse leks or within other mapped greater sage-grouse breeding or summer habitat, conduct these activities outside the period between March 1 and June 30.
2. Use hospital grade mufflers for compressors, pump jacks, or other motors necessary to run operations at the site. Mufflers will be pointed upward to dissipate potential vibration.
3. Establish company guidelines to minimize wildlife mortality from vehicle collisions on roads.
4. Restore appropriate sagebrush species or subspecies on disturbed sagebrush sites, if agreeable by the landowner. Use locally collected seed for reseeded where possible.
5. Install and utilize bear-proof dumpsters and trash receptacles for all food-related trash on location, following COGCC Rule 1204 a-1.
6. Encourage developers to pipe produced water, oil, and natural gas liquids to a central facility site for transport, in order to reduce truck traffic to each well pad site.
