CONDITIONS OF APPROVAL, IF ANY:

- 1) The venting or flaring of natural gas shall be allowed in accordance with COGCC Rule 912.
- 2) Typically, bradenhead valves are blown down for 30 days then shut in for 7 days and a follow up bradenhead test is completed and submitted. This procedure may repeated up to 3 times. If the final bradenhead test identifies a potential issue, further remediation would be required at that point.
- 3) Notify the local emergency dispatch or the local governmental designee of any natural gas venting or flaring.
- 4) The operator is required to obtain and maintain any required air permits from CDPHE.
