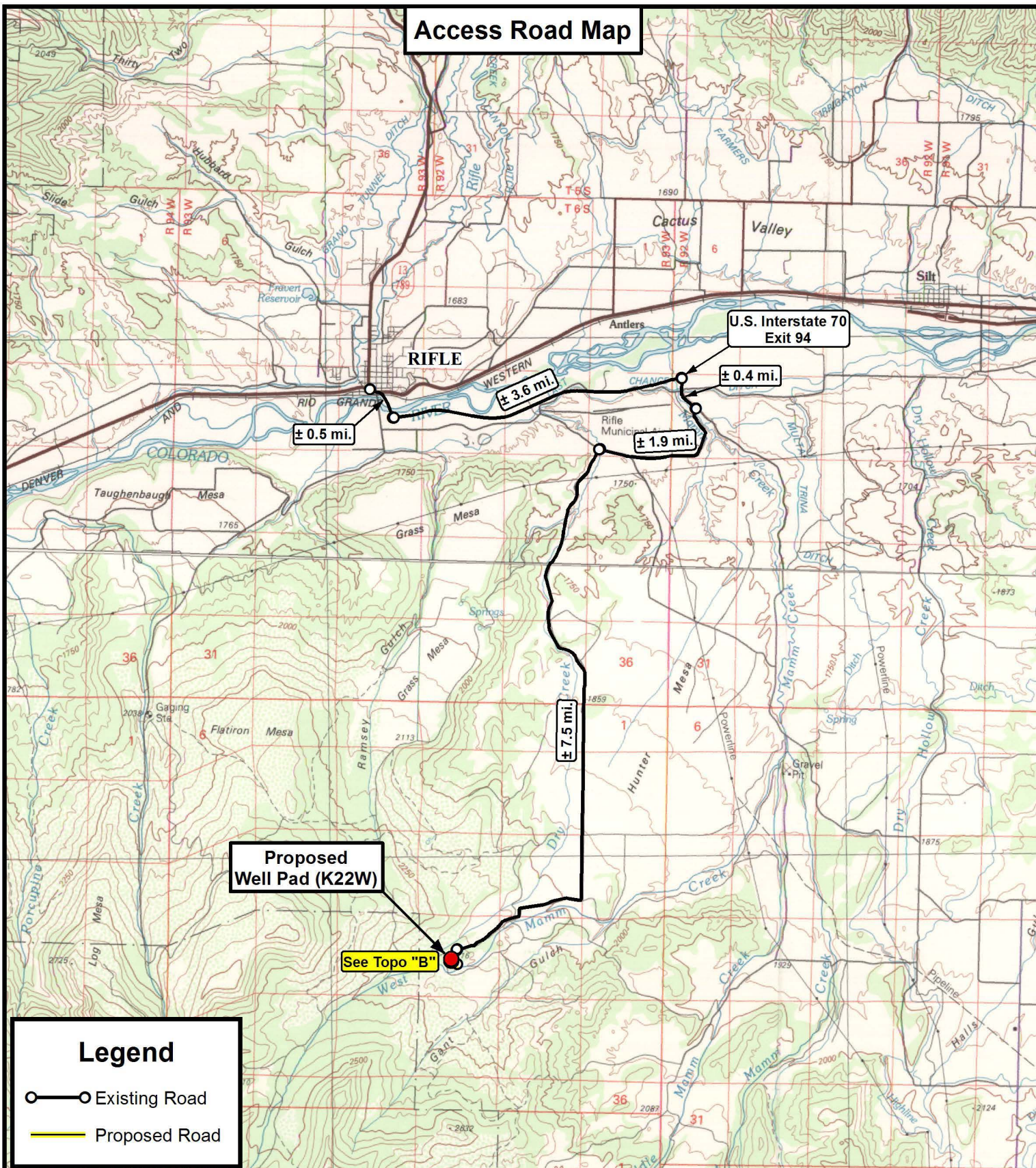


Access Road Map

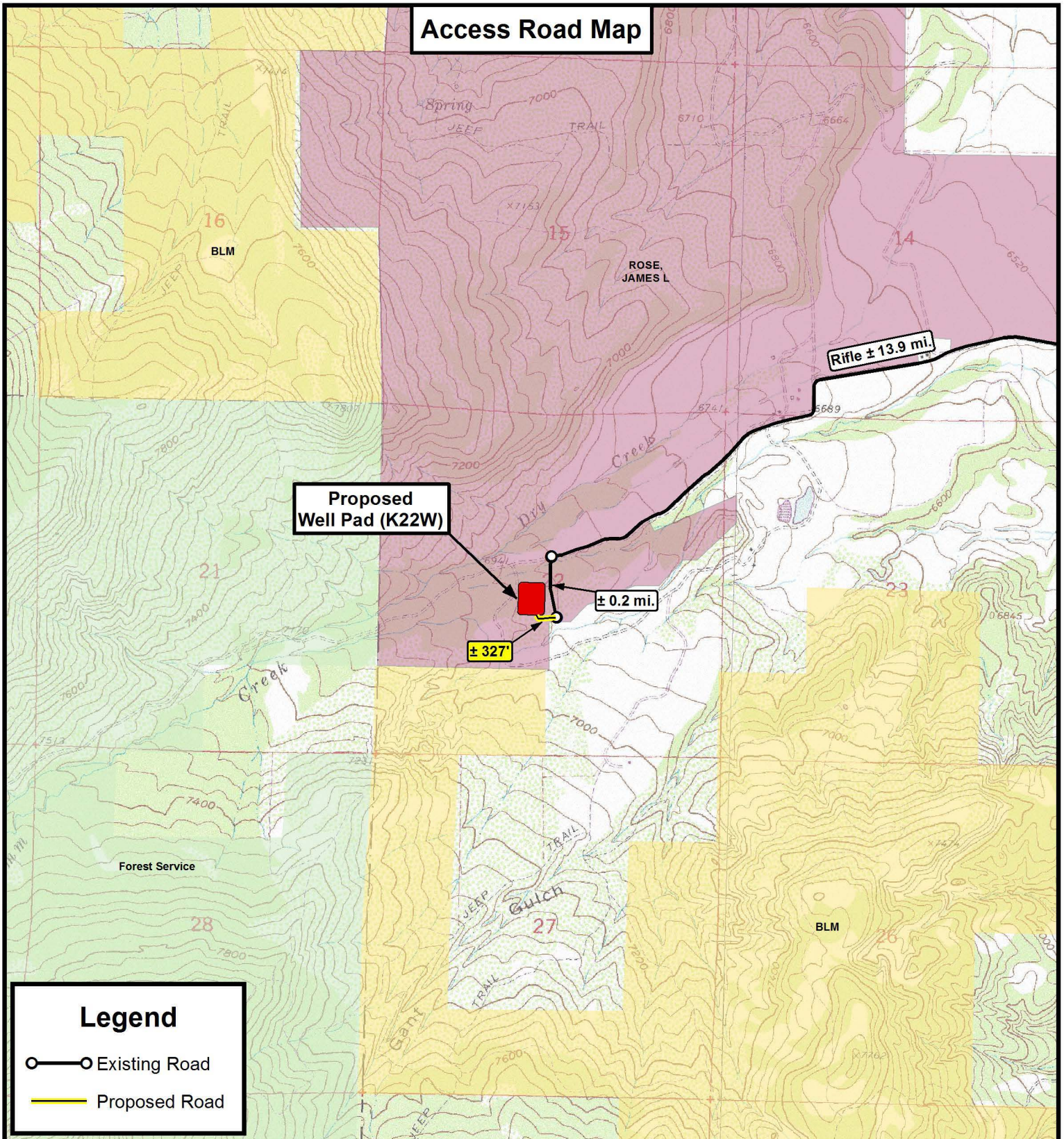

WELL PAD (K22W)

SECTION 22, T7S, R93W, 6th P.M.

PROCEED IN A SOUTHEASTERLY DIRECTION FROM RIFLE, COLORADO ALONG STATE HIGHWAY 13 APPROXIMATELY 0.5 MILES TO THE JUNCTION OF U.S. INTERSTATE 70 TO THE EAST; TURN LEFT ONTO U.S. INTERSTATE 70 AND PROCEED APPROXIMATELY 3.6 MILES TO EXIT 94 AT THE JUNCTION OF U.S. INTERSTATE 70 AND MAMM CREEK ROAD TO THE SOUTHEAST; TURN RIGHT AT EXIT 94 ONTO MAMM CREEK ROAD AND PROCEED SOUTHERLY THENCE SOUTHEASTERLY APPROXIMATELY 0.4 MILES TO THE INTERSECTION OF THIS ROAD AND GARFIELD COUNTY AIRPORT ROAD TO THE SOUTH; TURN RIGHT ONTO GARFIELD COUNTY AIRPORT ROAD AND PROCEED SOUTHERLY THENCE WESTERLY APPROXIMATELY 1.9 MILES TO THE INTERSECTION OF THIS ROAD AND WEST MAMM CREEK ROAD TO THE SOUTH; TURN LEFT ONTO WEST MAMM CREEK ROAD AND PROCEED IN A SOUTHERLY THENCE WESTERLY DIRECTION APPROXIMATELY 7.5 MILES TO THE INTERSECTION OF THIS ROAD AND AN EXISTING ROAD TO THE SOUTH; TURN LEFT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 0.2 MILES TO THE BEGINNING OF THE PROPOSED ACCESS FOR THE (K22W) WELL PAD TO THE WEST; TURN RIGHT AND FOLLOW THE PROPOSED ROAD STAKES IN A WESTERLY THENCE NORTHERLY DIRECTION APPROXIMATELY 327 FEET TO THE PROPOSED (K22W) WELL PAD.

TOTAL DISTANCE FROM RIFLE, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 14.2 MILES.
