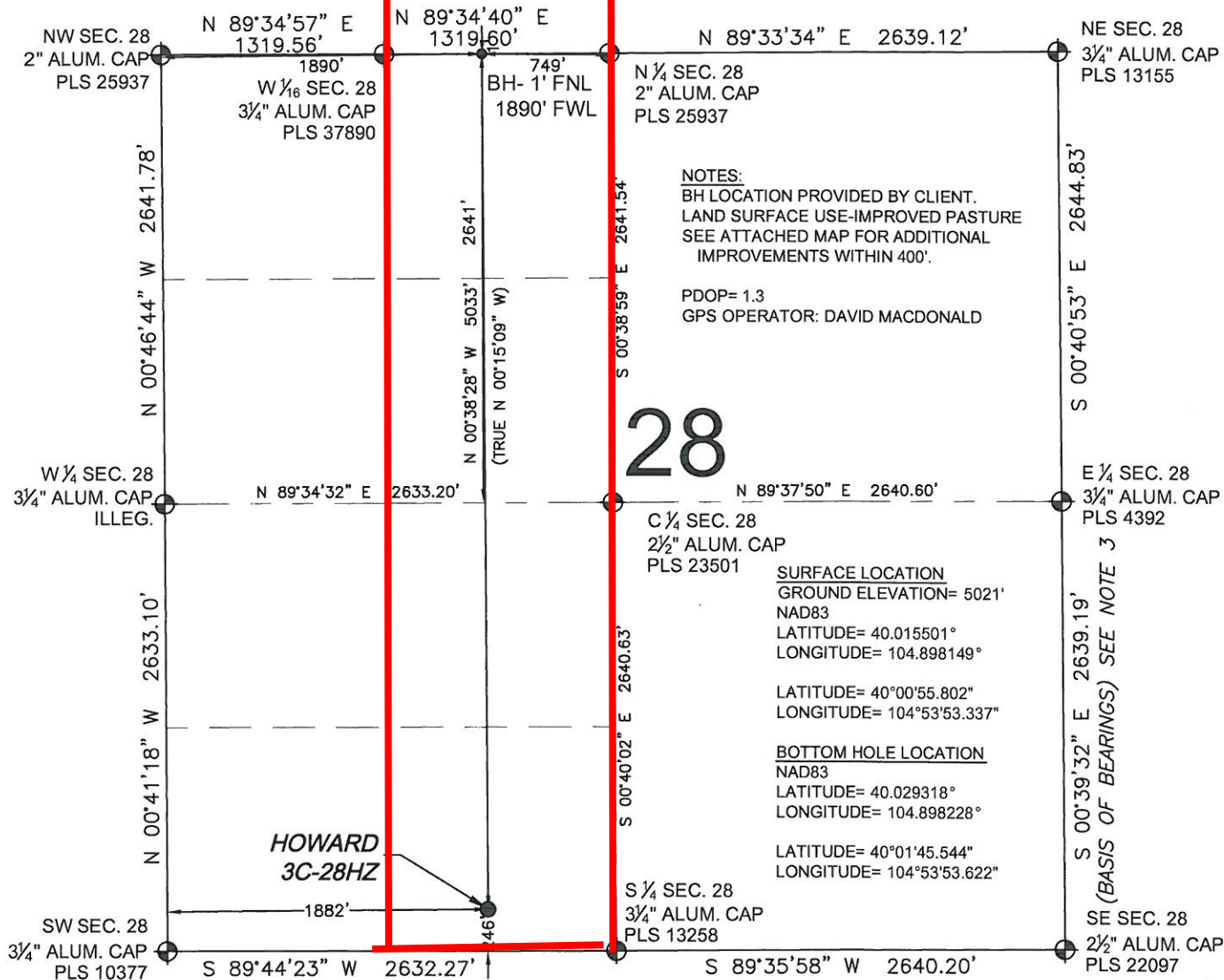

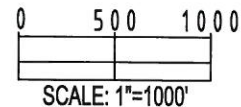
WELL LOCATION CERTIFICATE: HOWARD 3C-28HZ

 = EXISTING WELL

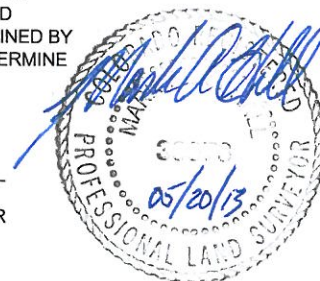
