- 1) SLW Ranch State B12-63-1HN (Target zone - Niobrara)
- 2) Surface equipment rated to 5000 PSI (as per NEI wellbore integrity BMP's)
- 3) Bradehead pressure event on 6/19/13 at 13:22 hrs from 14 PSI baseline to 561 PSI
- 4) Bradenhead pressure data downloaded on 6/20/13 and distributed. Pressure on surface casing was bled to a tank.
- 5) 6/20/13 Bradenhead event reported to COGCC

Procedure:

- 1) Bleed down surface casing pressure to a Tank (completed 6/20/13) and continue to monitor surface casing pressure only.
- 2) Perform Bradenhead Pressure test - completed 6/25/13
- 3) Review TOC and Aquifer coverage. TOC at 6042' w/Niobrara top at 6413', 371' cement coverage over Niobrara
- 4) Continue to monitor Bradenhead pressure and bleed off as required.
- 5) MIRU workover rig, pump and tank.
- 6) Control well with kill fluid.
- 7) POOH w/ 2 3/8" tbg. Lay down.
- 8) RIH w/bit and scraper. Tag fill if any. Clean out to PBSD (tally in) TOOH
- 9) RIH w/RBP. Set RBP @ +/- 6366', spot 2 sx of sand on top of RBP
- 10) Perform MIT
 - a) If passes, continue to step 11 and put back on production
 - b) If fails MIT, call Denver engineering for approval to P&A
- 11) Bleed off Bradenhead, unland casing
- 12) Trip in 1 1/4" tubing down annular w/mule shoe to 1595'; condition hole.
- 13) RU cement crew, pump 360 sxs 15.8ppg "G" neat cement, POOH to 595', roll hole clean leaving Bradenhead open
- 14) SI well overnight, run CBL recording new cement depths
- 15) Clean hole, retrieve RBP
- 16) TIH w/ 2 3/8" tubing , Land tubing
- 17) Return well to production under pumper guidance.
