This location is located directly south of another proposed Encana site, the Grant Elmquist 14H-C268. Depth to ground water was taken from water well permit #: 37439. In addition to the facilities equipment listed on the permit, there will also be a temporary water storage location adjacent to this pad. It will contain three 150' diameter tanks and be an additional four acres of temporary surface disturbance. The tanks would be removed immediately after completion operations are finished.
