PRM would like permission to expand the cutting pit to allow for on-site burial of the cuttings from deepening the well bore. The dried drill cuttings will be mixed with subsurface soil excavated from the proposed cuttings burial pit. The mixture will be buried under three feet of unmixed subsurface soil.

The well site soils have previously been sampled and the new drill cuttings will be analytically tested and the test results summary will be submitted for COGCC approval.
