1. Hold a pre-job safety meeting. Discuss all aspects of the procedure with any involved personnel. Identify and address any safety concerns before the job begins.
2. MIRU pulling unit. Kill well with produced water.
3. ND wellhead, NU BOP.
4. POOH with tubing. Replace joints as needed.
5. RU E-line.
6. RIH and set CIBP @ 7320'.
7. RIH with perf guns and shoot squeeze holes at 7300'.
8. RIH and set CICR @ 7280'.
9. Establish circulation and squeeze 200 sxs of class G neat cement.
10. Sting out of CICR and POOH and lay down 2-3/8" tubing. Send off to yard for inspection.
11. Run CBL and log from top of CICR to 5000'
12. RD E-line.
13. ND BOP, NU wellhead.
14. RDMO Workover rig.
