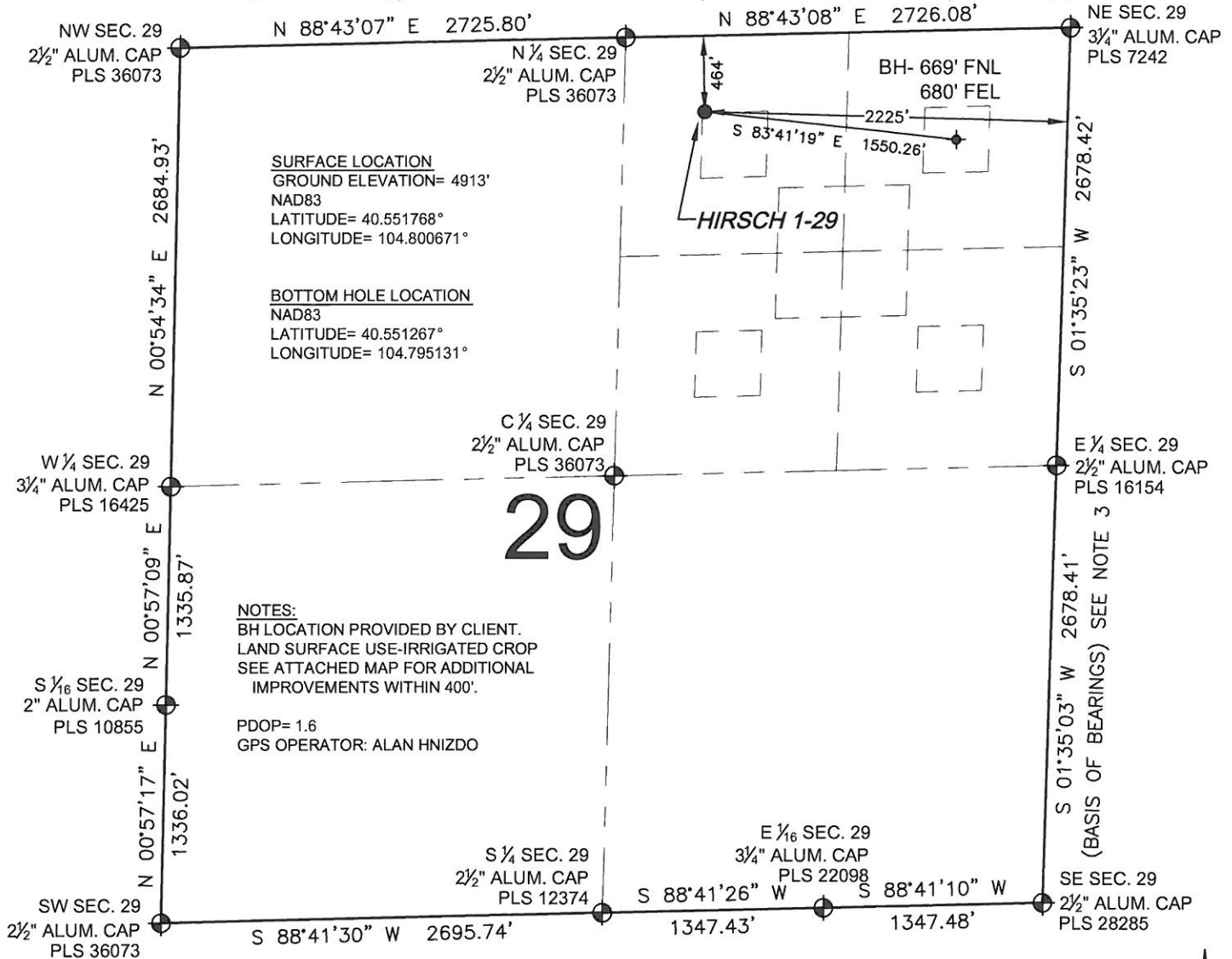


WELL LOCATION CERTIFICATE: HIRSCH 1-29

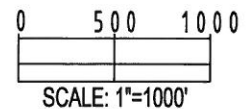
SECTION 29, TOWNSHIP 7 NORTH, RANGE 66 WEST, 6TH P.M.
