Operator Comments:

Carrizo drilled a Pilot on this well. The results indicated that the reservoir is isotropic. This means that the wellbore azimuth was not critical. Additionally, we had just completed micro-seismic on the Vawter & Rothe wells. These results indicated the spacing was much tighter than the original thoughts of 1 or 2 wells per 640. Upon gathering the data from the pilot and the micro-seismic, Carrizo decided to drill the well in a North/South direction to maximize recoverable reserves. Carrizo was unaware that type of move required a sundry. Carrizo was under the impression that this could be handled at the time the Form 5 was completed. This was the 13th well, February 2012, Carrizo drilled in Colorado. Since that time, Carrizo has had numerous conversations with the COGCC staff and has a better understanding of the regulations and requirements for wellpath changes.
