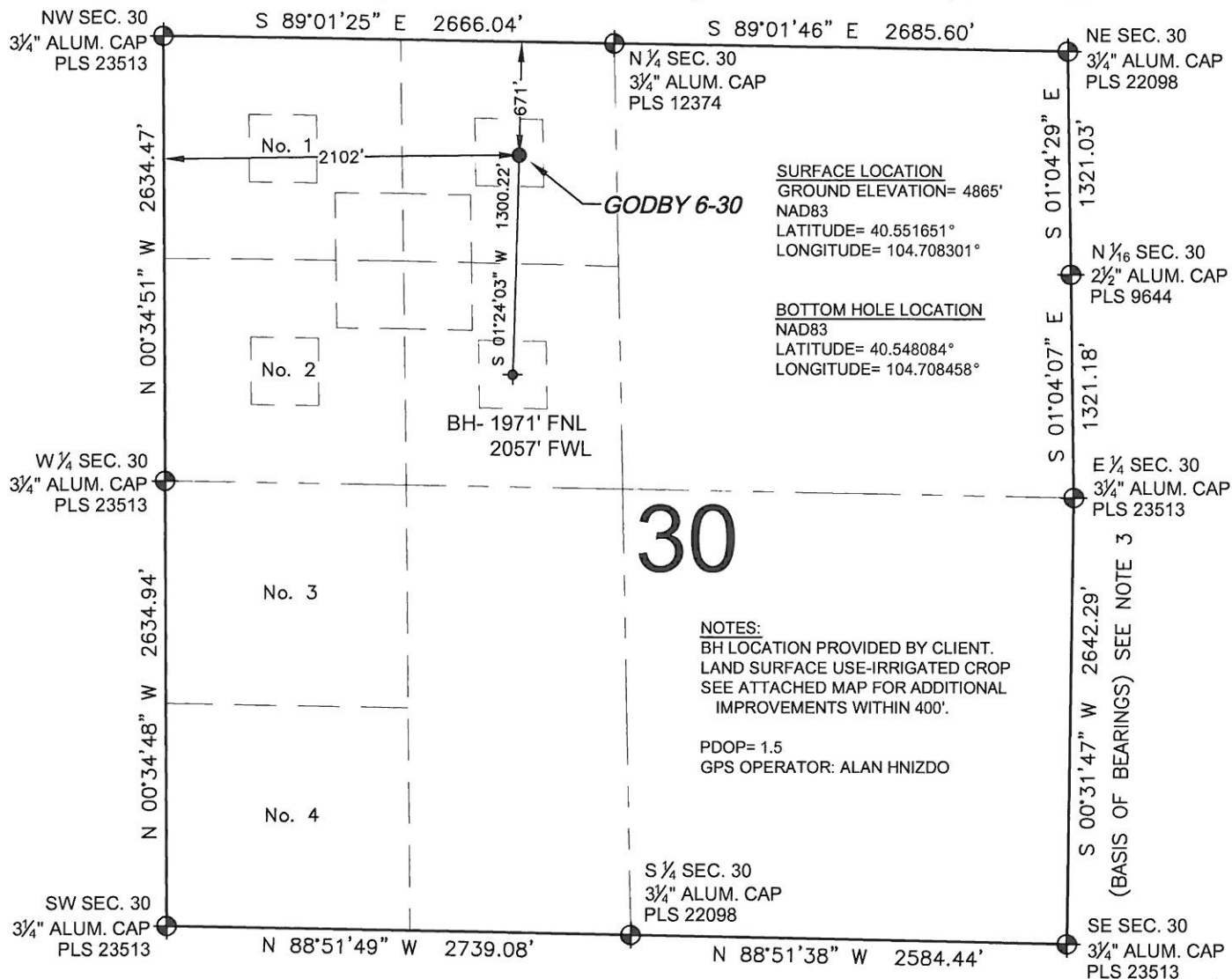


WELL LOCATION CERTIFICATE: GODBY 6-30
