Inspected the location in response to landowner inquiry regarding apparent dead vegetation near production facility and continuing south/southeast toward the DeJong USX AB13-06P. No spills or releases were apparent on the wellpad or production facility. Workover rig is on location. The stressed and dead vegetation follows the topography, with most dead or stressed vegetation in the low area west of a northwest-southeast trending ridge where vegetation is still green. Operator has collected surface soil samples from the stressed area and background areas for analysis for BTEX/TPH, SAR, EC, pH and results are pending. COGCC EPS will review analytical results with operator.
