ALL SOUND READINGS TAKEN DURING INSPECTION WERE IN COMPLIANCE FOR BOTH A AND C SCALE. DBA RADING AT 350' WAS 49 DBA AND DBC READING AT COMPLAINTANT RESIDENCE WAS 53 DBC. DURING INSPCTION IT WAS OBSERVED THAT WHEN THE LINE HEATER BURNER ACTAUTED THERE WAS A NOTICABLE INCREASE IN NOISE AND THERE WAS A NOTICABLE POPPING SOUND.
