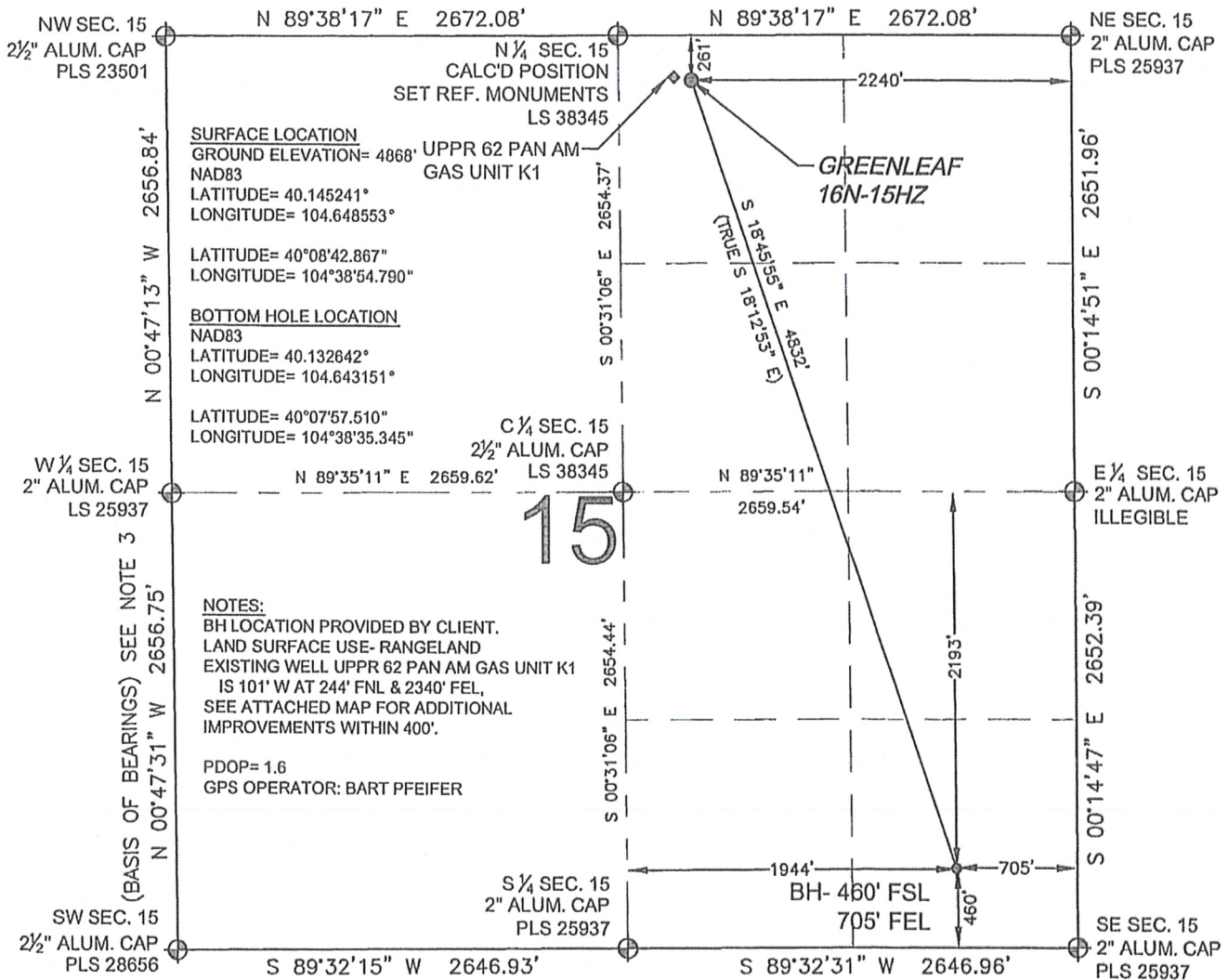

WELL LOCATION CERTIFICATE: GREENLEAF 16N-15HZ

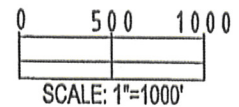

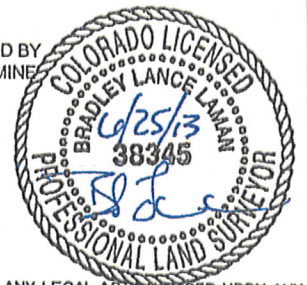
