Nearest building, public road, above ground utility, railroad, water well more than 5280 feet. Shallow surface water depression which is dry with no running water. located 116 feet South of well pad. Has to rain more than 2" in a short period of time for depression to run water. Dirt berm will be installed on the South side of well pad to protect surface water depression. One oil tank, one water tank and one separator will be located at the Ma-State # 2 tank battery, located Sec. 24: SWSW, T10S, R56W. No additional surface disturbance will be required at the Ma-State # 2 tank battery.
