("Noble") hereby gives notice to you that it intends to commence operations for the drilling of a well or wells for oil and/or gas on the referenced lands no sooner than April 19, 2013. As surface owner you have the responsibility for notifying any affected tenant of the proposed operations.

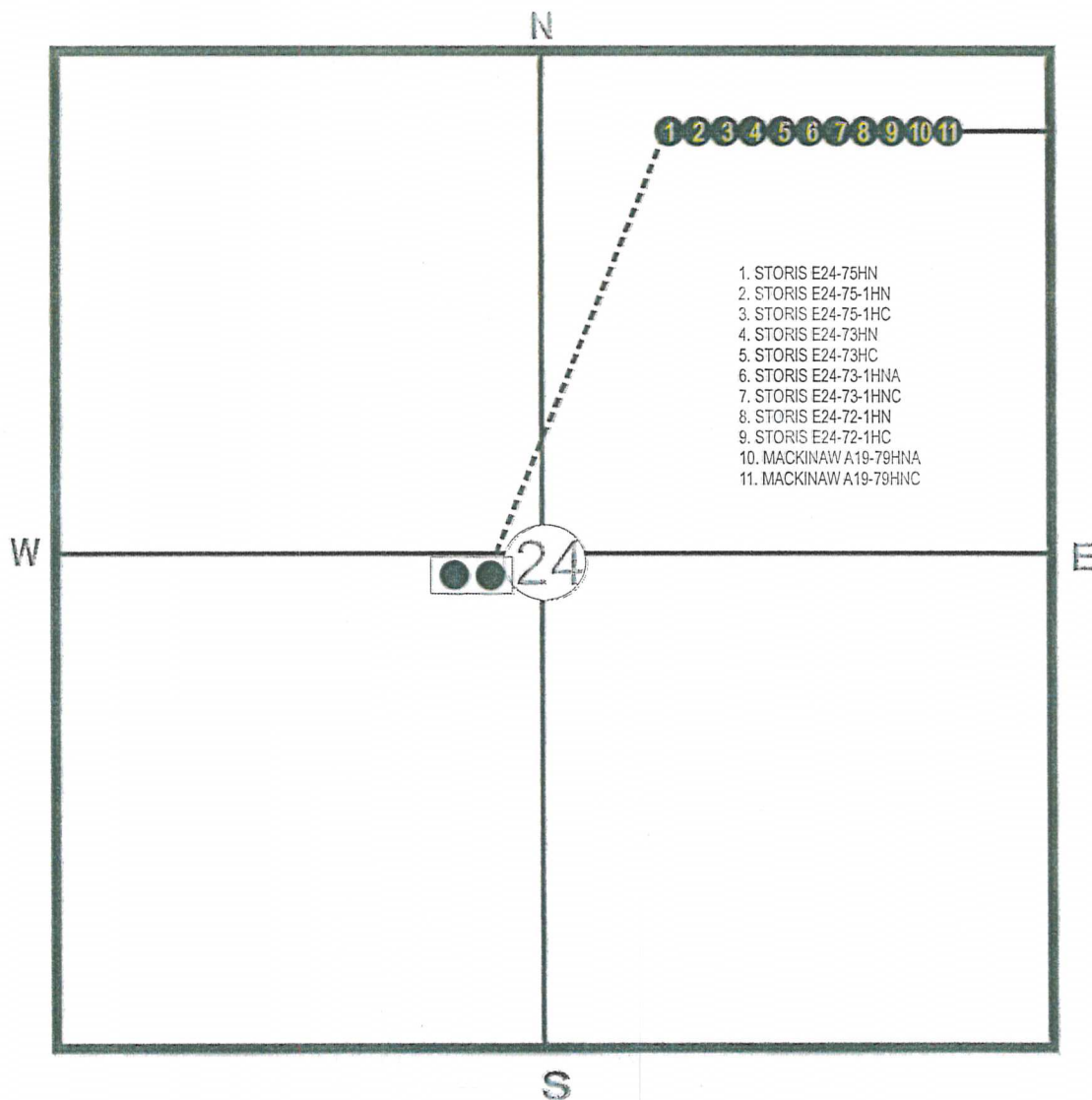
