## **RE: Noble Energy, Inc., Healy Production Facility Site, Wildlife Assessment**

Mr. Verbit:

On March 20, 2013 Savage and Savage conducted a wildlife assessment at the proposed Healy production facility site. A standard production facility is currently located at the site and will be expanded to approximately 4.5 acres. The site is located northwest of the intersection of Weld County Roads 64 and 47. Specifically, the site is situated within the SE/4 SE/4 Section 26, Township 6 North, Range 65 West, 6<sup>th</sup> Prime Meridian, Weld County, Colorado.


The Healy development site is surrounded by agricultural fields. There are eight cottonwood trees that will be removed as part of this project. These trees skirt the outline of an old homestead foundation. Several of these trees are senescent and there are no nests located in the trees. There are other cottonwood trees in the area along Weld County Road 64 east and south of the site; no nests were identified in these trees.

Our firm conducted a pedestrian survey of a substantial tree barrier that surrounds a homestead west of the site. The tree barrier is a "U" shape that faces Weld County Road 64. This survey was conducted in order to determine if raptor nests or other species of

concern may be located in the area. During the survey one magpie nest and approximately 12 squirrel nests were identified. The landowner, Mr. Lyster, was interviewed and he indicated that he observes owls in the area.

The Healy site is scheduled for development from September through October of 2013. Most migratory bird nesting occurs in Colorado from April 1 to July 15. Great horned owl nesting season occurs from February 1 to May 31. Since the Healy site is scheduled for development in the fall, the general migratory bird nesting season and the great horned owl nesting season will be avoided.

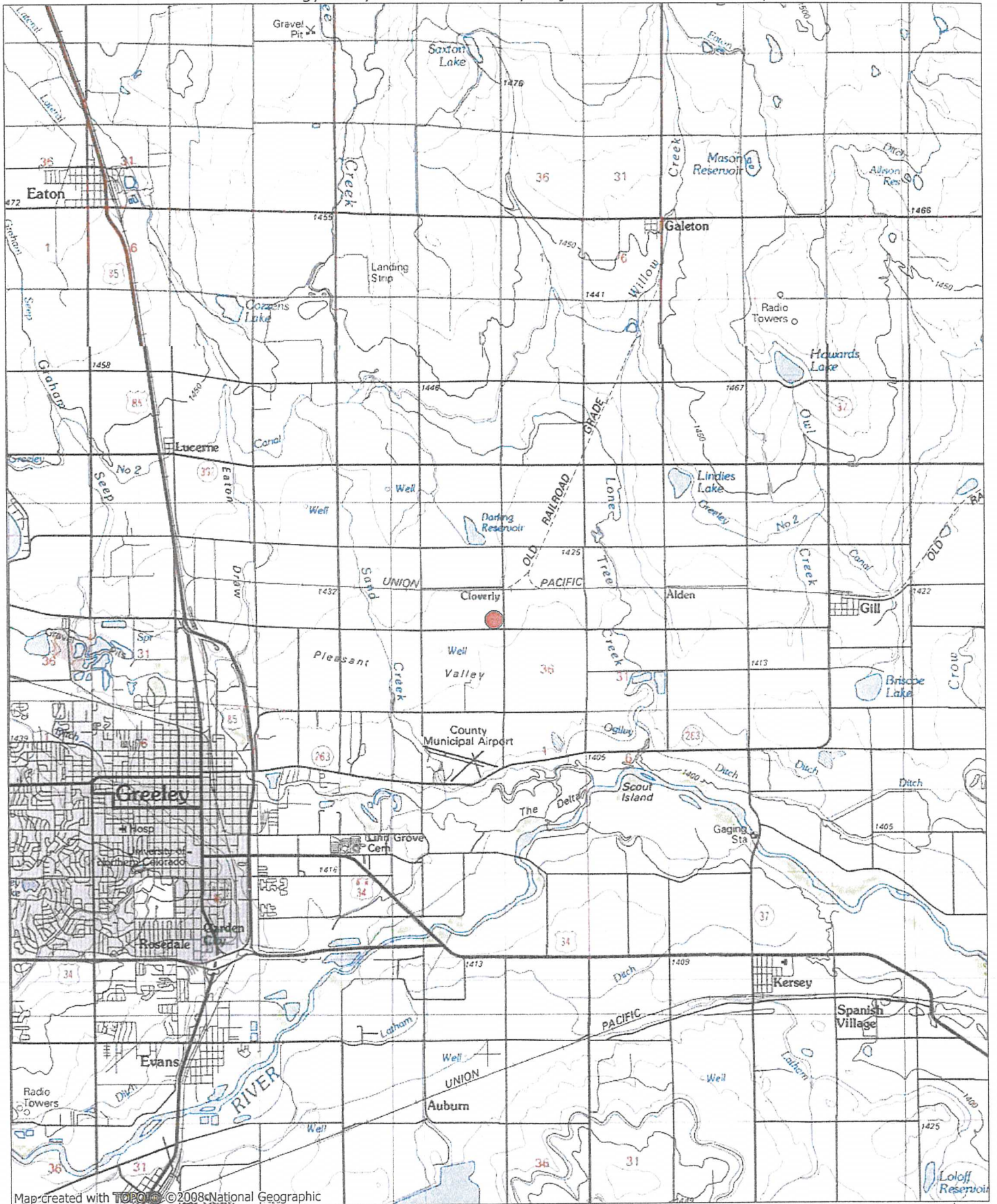
