No disturbance of surface water depression during drilling operations Dirt berm will be placed on the East and South side of well pad to protect surface water depression. NRCS map shows 220-access denied area. Field observation performed for plant species. Water well approximately 1050' Northwest of well stake will not be disbrubed by drilling operations. Operator will perform ground water testing on said well before drilling operations begin.

Drilling pits closed and reclaimed within 3 months weather permitting. Topsoil will be separated and spread on drill site as final operation before reseeding operations which will be completed within 6 months weather permitting.
