- 1) MIRU Workover rig, pump & tank.
- 2) Control well with kill fluid
- 3) RIH w/ Bit & Scraper. Tag fill if any. Clean out to PBTD (tally in). TOOH
- 4) RIH w/RBP. Set RBP @ +/-6411', spot 2 sx of sand on top of RBP. Test RBP 2,000psi. TOOH
- 5) Bleed off bradenhead, unland casing
- 6) Trip in 1 1/4" tubing down annular w/ mule shoe to 1600', condition hole.
- 7) RU cement crew, pump 360 sxs 15.8ppg "G" neat cement to cover interval from 500'-1500'.
- 8) POOH with 1 1/4" tubing, land casing.
- 9) SI well overnight, run CBL recording new cement depths
- 10) Clean out hole
