Distances are measured from HWY 52 4I-32H-O268 well head. The HWY 52 32H-O268 horizontal wells will be located approximately 1800' east from Encana's proposed horizontal location, the File 32H-K268. Encana Oil & Gas (USA) Inc. is working towards utilizing a centralized gathering facility –yet to be permitted – for this location in order to reduce the equipment placed on the subject site. Due to multiple factors including the timing of necessary permits and operations, Encana Oil & Gas (USA) Inc. is planning this location with two (2) options: 1. All necessary equipment on this location without centralized gathering and 2. Minimal equipment placed on this location with centralized gathering. Option 2 will contain the following equipment: 16 separators, 1 pump skid, 2 pig launchers, 3 meter houses and 1 electrical skid and will be reclaimed to 3.5 acres. A temporary completions area located adjacent to the pad will be utilized during completions operations that will cover approximately 4 acres of land for up to 3 fresh water storage tanks!; see attached map for reference.
