Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the Sec 4: E/2, T3N, R64W, creating a 318-acre wellbore spacing unit for the Niobrara formation. NEI is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A(l).e(6). Copies of the required notice letter(s) is/are on file at the NEI offices. The required thirty (30) day notice period has elapsed absent the receipt by NEI of an objection to said proposal by the owner(s) within the proposed spacing unit for this well.

Thank you for your attention to the enclosed. NEI respectfully requests that the COGCC review the enclosed information and approve the Application for Permit to Drill the captioned well.




LATITUDE AND LONGITUDE EXHIBIT

Petroleum Field Services, LLC has determined the surface location of the MARIE D04-74-1HN to be 236' from the SOUTH line and 1813' from the EAST line and the bottom hole to be 535' from the NORTH line and 1650' from the EAST line as measured at right angles from the section line of Section 4, Township 3 North, Range 64 West of the Sixth Principal Meridian, County of WELD, State of Colorado.
