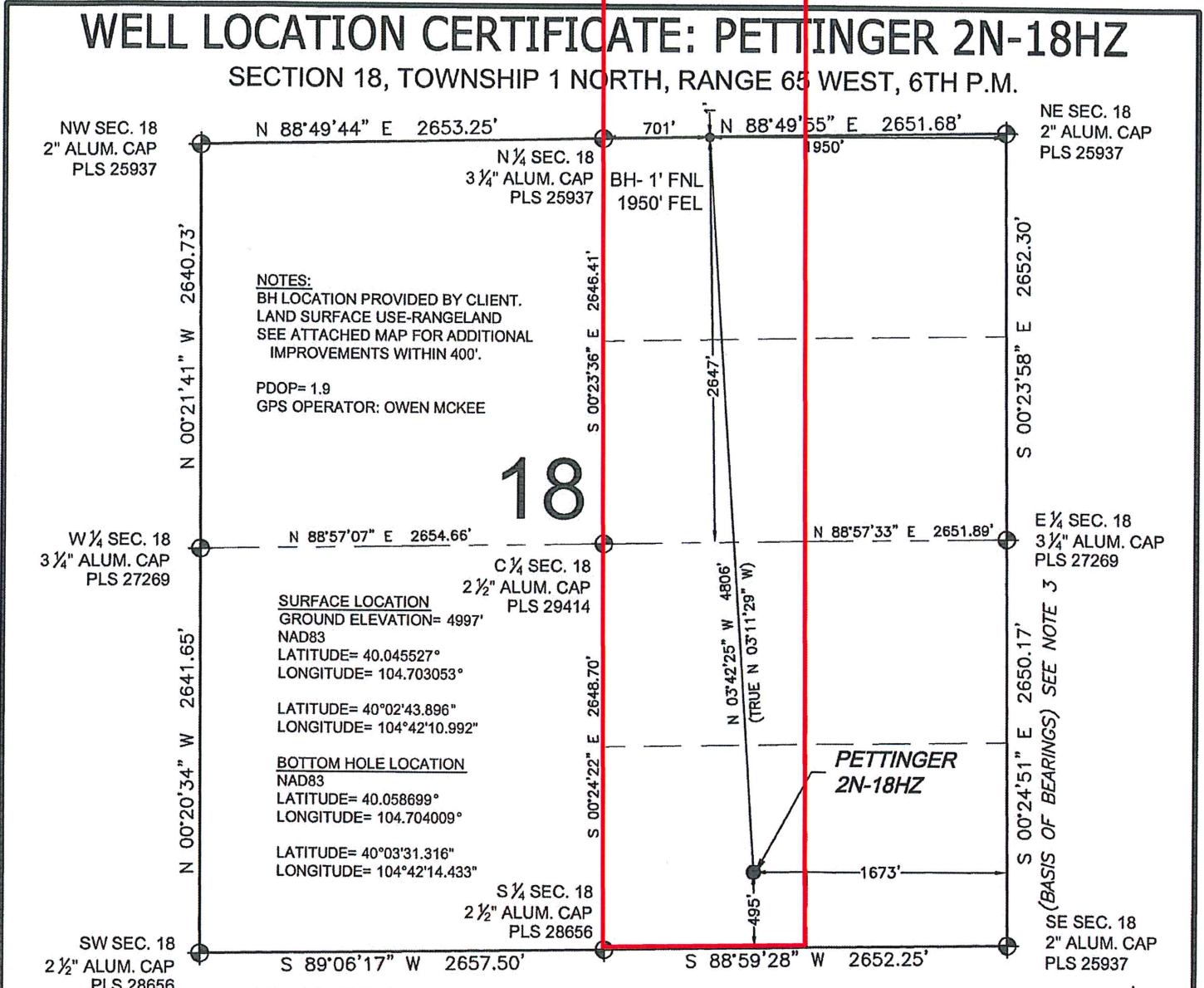

WELL LOCATION CERTIFICATE: PETTINGER 2N-18HZ

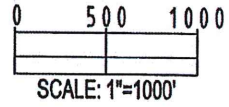
