Reduced analytes approved as requested. Note: You need to lower your limit for the arsenic - <2.5 mg/kg does not approach our standard of 0.39 mg/kg.

Please also make sure you collect some sidewall samples to confirm lateral removal as well as removal at depth. We want to make sure it is all appropriately addressed.

Attached are the lab results from the surface samples that were collected on June 13th. I also included a summary table, which shows the background sample that was collected for the first two releases on May 23rd. The map shows the GPS locations of the three samples. The background sample is not on there, but all three releases are very close, so I'm assuming that we don't need another background.

As of right now, we are planning on collecting soil samples tomorrow from the bottom of the excavated area that Tom Fox dug out. Based on these results, we would like to request a reduced list of analytes, and sample for TPH, BTEX, naphthalenes, inorganics, and Boron only.
