- 3 POOH w/ packer and tubing
- 4 Remediate perforations with class G cement
- 5 POOH w/ down hole equipment
- 6 Drill out cement and test to 1,000 psi
- 7 RIH with tubing and return to production
- 8 Submit subsequent report
