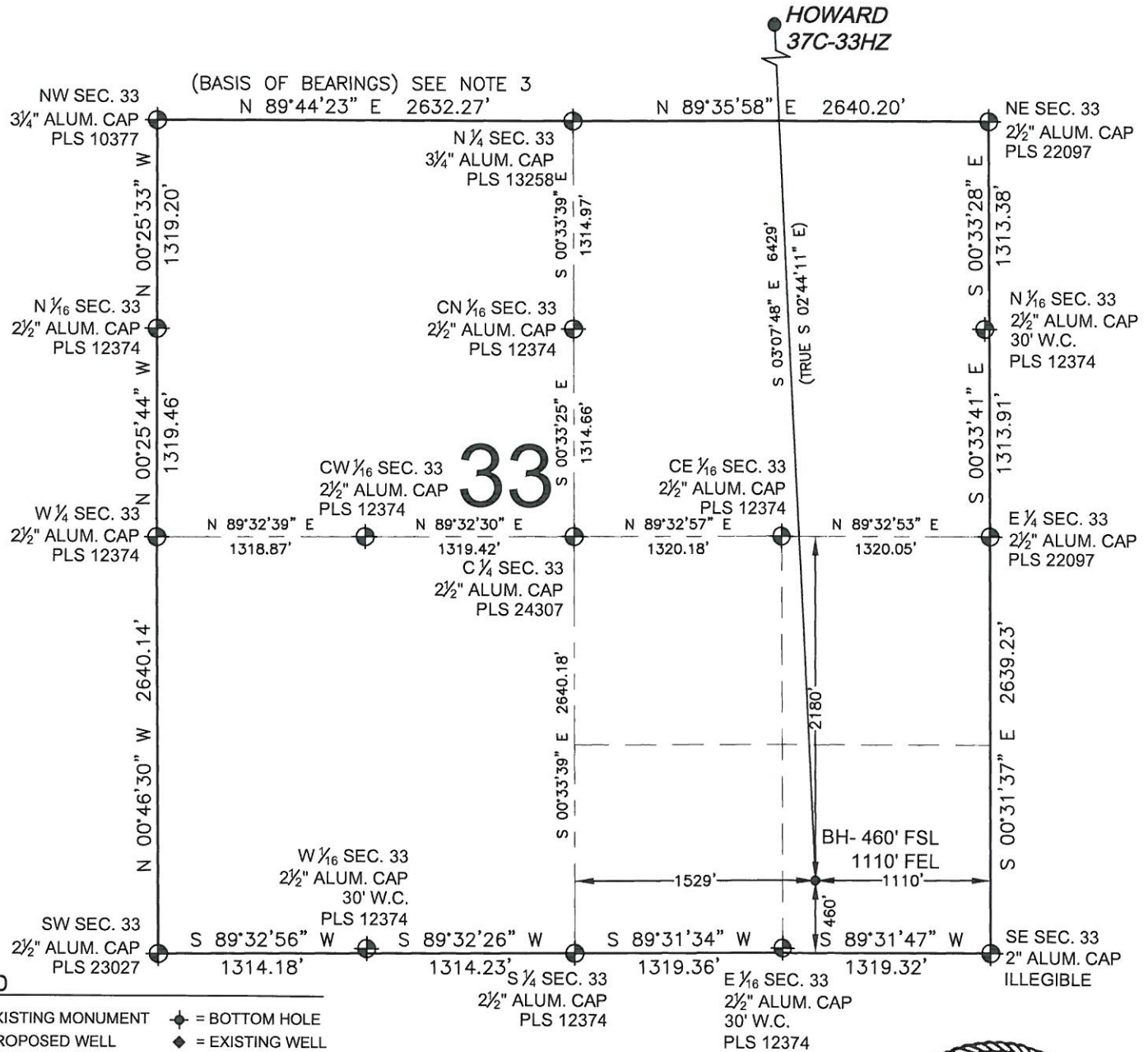




# WELL LOCATION CERTIFICATE: HOWARD 37C-33HZ

## SECTION 33, TOWNSHIP 1 NORTH, RANGE 67 WEST, 6TH P.M.

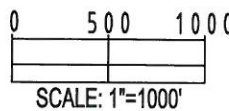


**LEGEND**
