Dear Patricia Nash:

Encana Oil & Gas (USA) Inc. ("Encana") staked the above mentioned wells at surface locations as noted above (see attached Well Location Certificate). These wells are being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 318A(l) known as the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule (Except the City and County of Broomfield). This rule states that all boundary infill wells be drilled from the same surface locations as previously designated in Rule 318A(l).a.(1) which reads:


"The Greater Wattenberg Area ("GWA") is defined to include those lands from and including Townships 2 South to 7 North and Ranges 61 West to 69 West, 6th P.M. In the GWA, operators may utilize the following described surface drilling locations ("GWA windows") to drill, twin, deepen, or recompleat a well ("GWA well") and to commingle any or all of the Cretaceous Age formations from the base of the Dakota Formation to the surface:

- (1) A square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' window");

Per your request the Rodman Bruntz 2A – 26H and Rodman Bruntz 2B-26H were staked at a location between 324' and 335' northeast of the defined 400' window. Encana respectfully requests your consent to a surface exception location for the Rodman Bruntz 2A – 26H and Rodman Bruntz 2B – 26H Wells by waiver of the COGCC Rule 318A(l).a (1).
