The COGCC and LGD for Garfield County were notified of the H2S reading within 48 hours via email (7/12/13). Additional treatments were immediately added to the tank and it was rolled until the field meter indicated a reading of 0 ppm. Measurements collected 50 feet away from the tank were 0 ppm.
