Nearest water well permit #202390. The surface location of this well is an exception to Rule 318A.a and to Rule 318A.c. This well is not within the GWA surface location window and does not meet the twinning requirement due to the number of wells planned for this area and at the request of the surface owner. An exception location request letter and signed waivers are attached to the Form 2 and Form 2A. The Boyd 2N-32HZ and Boyd 28C-32HZ wells will use oil based mud and the Boyd 27N-5HZ will use water based mud. Each Form 2 reflects individual mud type.
