During the post completion phase of the Cow Skull 11-89-18 #2 project, we collected water quality data from a water well as per Rule 608. Samples were extracted by a qualified environmental scientist and analyzed for the following: natural gases, metals, inorganic/organic compounds, bacteria and natural attenuations. SG is providing the post completion WQ results for the Cow Skull 11-89-18 #2 late, due to technical difficulties. Information found on the state engineers website pertaining to the sampled wells location (Lat/Long), was inaccurate leading us to believe that the well was not located within 1/4 mile of the proposed well. On 6/12/2013 Brett Francois (SG Intrests) collected WQ samples and accurate location information. EDD format submitted to Arthur Koepsell via email.
