NEI's proposed wellbore spacing unit consists of the Sec 13: SW/4SW/4, Sec 14: SE/4SE/4, Sec 23: E/2E/2, Sec 24: W/2W/2, T6N, R65W, creating a 402-acre wellbore spacing unit for the Niobrara formation. NEI is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A(I).e(6). Thank you for your attention to the enclosed. NEI respectfully requests that the COGCC review the enclosed information and approve the Application for Permit to Drill the captioned well.





Proposed 401.71± acre spacing unit





Bottom Hole Location


