- 1) New Horizontal Well = SLW Ranch State B01-63-1HN (Target Zone= Niobrara) 255' away from lateral
- 2) Surface Equipment Rated to 5000psi, RBP set in prod csg (as per Noble Wellbore Integrity BMPs)
- 3) Bradenhead Pressure Event on 6/2/13 at 23:03HRS from 2Psi Baseline to 385Psi.
- 4) Bradenhead Pressure data downloaded on 6/2/13 and distributed. Pressure on Surface Casing was bled to a tank.
- 5) 6/3/13- Bradenhead Event Reported to COGCC
- 6) 6/3/13 Emergency P&A procedure verbally approved by COGCC.

Procedure:

- 1) Bleed down Surface Casing Pressure to a Tank (completed 6/3/13)
- 2) Review TOC and Aquifer Coverage. TOC at 6062' with NIOBRARA TOP at 6428', 366' Cement Coverage over NIO.
- 3) Rig up to investigate cause of pressure event
- 4) P&A prior to resuming fracing of SLW Ranch State B01-63-1HN according to verbally approved P&A procedure below
- 5) Set CIBP @ 6347' (100' above Nio perms @ 6447'), dump bail 2 sks cement
- 6) Set CIBP @ 6247', dump bail 2 sks cement
- 7) Cut 3 1/2" 9.3 N-80 csg @ 5000' and POOH laying down
- 8) RIH with tubing down to 5000' and pump 200 sks 15.8 ppg class G stub plug from 5000'-4679'
- 9) If unable to maintain circulation throughout cementing, tag stub plug
- 10) Pull up hole, pump 100 sks 15.8 ppg class G cement plug from 2500'-2164'
- 11) Pull up hole, pump shoe plug from 350'- surface
- 12) Wait and top off surface if needed
- 13) Dig up around well head, cut and cap surface 6'-8' below ground level
- 14) Backfill hole and reclaim land
