7)Trip in 1 1/4" tubing down annular w/ mule shoe to 4850'; condition hole
8)RU cement crew, POOH to 4800', pump 136 sxs 13.5ppg 50/50poz cement bringing cement to 4230', ~250' above top of Sussex.

9)POOH above 4230', roll hole clean. POOH to 720', condition hole
