Attached with this COGCC Form 4 is the TR 31-5-697 Sampling Summary Report for the groundwater samples collected in the second and third quarter of 2013 along with wells logs and completion diagrams for the three additional monitoring wells which were installed in June of 2013. The COGCC remediation number is 5258.

Well installation and sampling summary:

On June 19 and 20, 2013 a CME 55 LC track rig was utilized to drill three additional monitoring wells in an effort to further define the extent of groundwater contamination down-gradient of existing monitoring well MW4.

MW-5 was drilled to a total depth of 40 feet. Based on field observations it was completed in the weathered shale and siltstone deposits. No evidence of hydrocarbon impact was observed in the entire drilling interval. The subsurface was very moist to saturated from 28-40 feet bgs. 20 feet of screen was installed beginning at 20 feet bgs to the total depth of 40 feet bgs (see attached well summary diagram).

On July 11, 2013 depth to groundwater was recorded at 29.47 feet below top of casing and samples were collected (see attached data summary table 1 and 2). Analytical results indicate no hydrocarbons are present.

MW-6 was drilled to a total depth of 30 feet. Based on field observations it was completed in gravel, sand, and silt deposits. No evidence of hydrocarbon impacts were observed in the entire drilling interval. The subsurface was very moist to saturated from 20-30 feet bgs. 15 feet of screen was installed beginning at 15 feet bgs to the total depth of 30 feet bgs.

On July 11, 2013 depth to groundwater was recorded at 25.35 feet below top of casing and samples were collected. Benzene concentrations tested at 1.5 ug/L which is below the COGCC allowable concentrations for groundwater.

MW-7 was drilled to a total depth of 30 feet. Based on field observations it was completed in clayey gravel deposits. No evidence of hydrocarbon impact was observed in the entire drilling interval. The subsurface was very moist to saturated from 25-30 feet bgs. 15 feet of screen was installed beginning at 15 feet bgs to the total depth of 30 feet bgs.

On July 11, 2013 depth to groundwater was recorded at 28.42 feet below top of casing and samples were collected. Analytical results indicate that no hydrocarbons are present.

The results of the second and third quarter water sampling of all monitoring wells installed for this project are summarized in the attached summary table 1 and 2. The results indicate that the benzene levels continue to decrease in MW-2, MW-3, and MW-4. WPX is evaluating this data in order to propose remedial actions to enhance natural attenuation of this site. The remediation proposal will be submitted to COGCC via a subsequent Form 4.
