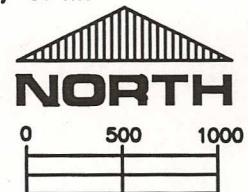

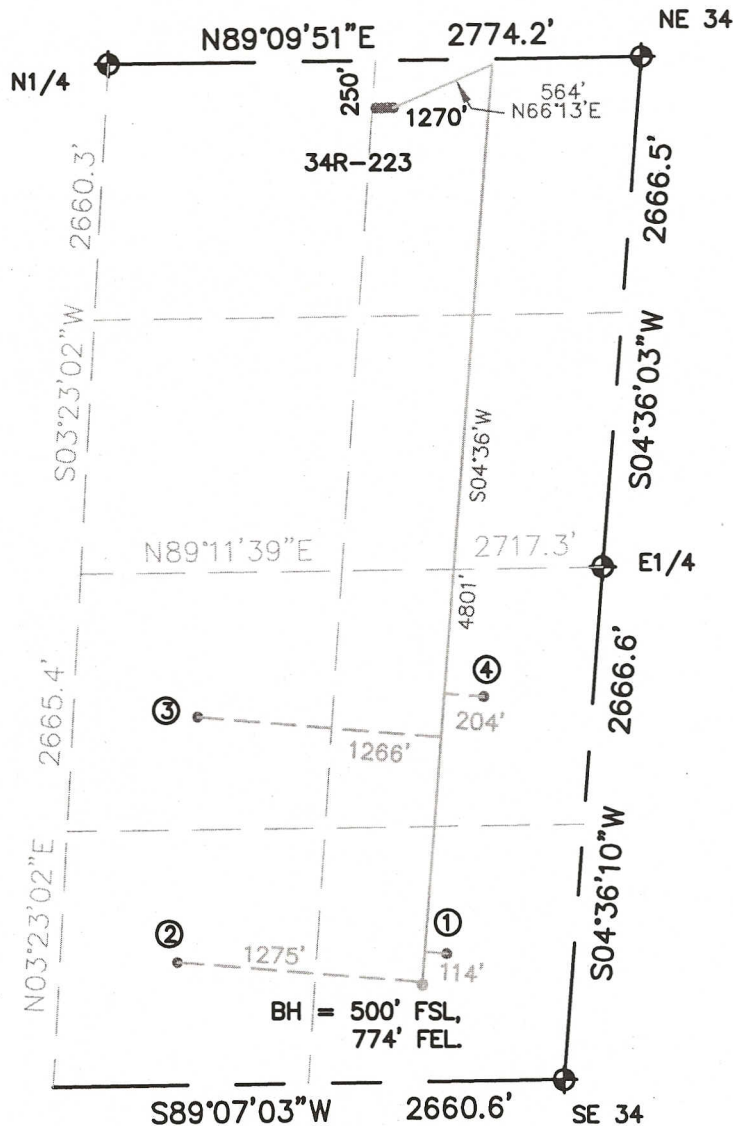

E1/2 SECTION 34, TOWNSHIP 7 NORTH, RANGE 66 WEST, 6TH P.M.

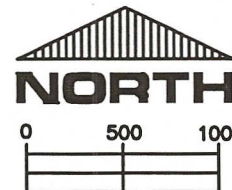
